The chairs of the working groups will be available to preside over working group sessions. This event will give all partners present the opportunity to discuss all principles elaborated so far and to prepare a final draft version to be presented to the this year's General Assembly in November for adoption.



Please note that you will receive an official invitation in the upcoming days.



RECENT ACTIVITIES

G-20 agreed on an Anti-Corruption Action Plan

The G-20 was established in 1999, in the wake of the 1997 Asian Financial Crisis. Its purpose is to bring together developed economies with emerging economies to stabilize the global financial market and to serve as the primary forum for discussing, planning and monitoring international



economic cooperation. The 2010 G-20 Seoul Summit was the fifth meeting of the G-20 heads of government, which took place on 11 and 12 November 2010. South Korea was the first non-G8 nation to host a summit of this kind. The Leaders agreed on an Anti-Corruption Action Plan while at this meeting. Laxenburg (near Vienna). This Summer Academy will subsequently continue along the tradition of the previous International Anti-Corruption Summer School (IACSS) held in 2007, 2008 and 2009, as well as last year's alumni meeting.
